**Call to Order:**

Meeting called to order at 09:00am by Commissioner Price

- A. The Commission meeting schedule that was distributed to the Commission in their packet for the March 16, 2021 meeting is incorrect. The correct schedule has been sent to all Commissioners and will also be attached to these meeting minutes for reference.

**New Business:**

- A. Discussion on recent eligible candidates to fill a vacancy in the firefighter ranks due to the resignation of Trevor Korinik
  - The Commission was briefed by DC Kane on the process to find the next eligible candidate to fill the vacancy left by the departure of Trevor Korinik. Candidate Pedersen had verbally passed on our conditional offer and candidate Fabsist had accepted the conditional job offer and had begun the process. He later called DC Kane on March 23, 2021 and decided not to accept the job (took a job with Long Grove FPD).
  - The next candidate on the list, Ryan Ahlgrim was contacted and he declined a conditional offer. The last candidate was Ryan LeBreux and he expressed interest in the job but had some issues with his IDPH Paramedic license. Mr. LeBreux was asked to come in and speak with DC Buschick and DC Kane on March 29, 2021 and discuss his issues and a possible conditional offer. DC Kane advised the Commission that he would update the Commissioners following their discussion with candidate LeBreux.

- It was discussed that since the Commission was down to the last eligible candidate on the new hire eligibility list that a new testing process will need to commence whether Mr. LeBreux is offered and accepts a conditional offer or not. A June 19, 2021 examination date was proposed by DC Kane. This test date would secure a new eligibility list to be finalized and posted in late August 2021. A preliminary testing scheduled was discussed with Commissioners.

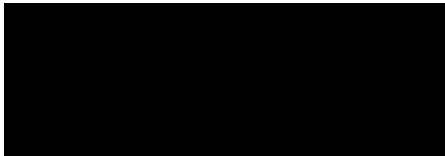
**Public Comments:**

The next regularly scheduled Fire Commission meeting will take place on Tuesday, April 20, 2021 beginning at 09:00 at Wauconda Fire Station 1.

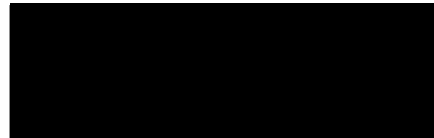
**Adjournment:**
