STAFF REPORT: Chief Geary informed the board that the Monthly Report was included in their packet this month, this report is also shared with the Fire Rescue Association so that they continue to see the monthly activity of the district. Members of the Daughters of the American Revolution stopped by for a visit and to drop off snacks and share pictures and stories. Division Chief DaValle shared the district annual report with the individuals that attended the United Partnership meeting. Chief Geary also extended an invitation for the district sponsored Luau on Phil's Beach in September. Director Steingart informed the board that the district received approximately \$16,000 in CURES money. There are \$1.6 Million in FEMA Grants available that should hopefully announce recipients soon as there hasn't been any since June. Deputy Chief Kane updated the board with the interview schedule for the Fire Commission Full Time Testing process. One of our part time employees scored a 100% on the written exam. The final list will be posted on August 24th. There will be 2 individuals hired right away due to a retirement and the vacancy. Division Chief DaValle informed the board of a meeting he and Chief Geary had with the new mayor of Wauconda. The new mayor is very interested in bettering the plan review and inspection process to increase building safety in Village limits. Division Chief Miller has been tirelessly working with Round Lake and Grayslake Fire to create MOUs for training at Station 3.
